History of 26th July

- ◆ **1614** : Jahangir welcomed the Rana of Mewar.
- ◆ **1876** : The Indian Association was established in Calcutta.
- ◆ **1966** : India's famous scholar Vasudev Sharan Agarwal passed away.
- ◆ **2008** : 21 blasts took place in Ahmedabad city of Gujarat. 56 people were killed and more than 200 were injured in this accident.
- ◆ **1844** : India's famous educationist Gurudas Banerjee was born.
- ◆ **1956** : Egypt captured the Suez Canal.

Current Affairs Related to 26th July 2024

- ◆ According to the bulletin issued by the Lok Sabha Secretariat, the central government will introduce six new bills during the monsoon session of Parliament running from July 22 to August 12. To facilitate business transactions, the Indian Aircraft Legislation 2024 aims to replace the Aircraft Act of 1934 and simplify laws related to civil aviation.
- ◆ Union Minister of Minority Affairs and Parliamentary Affairs Kiren Rijiju inaugurated the Lok Abhinandan Parv in New Delhi. Lok Ekta Parv is being organized to draw the approvals, programs and permits of the Ministry of Minority Affairs under its 100 Divine Programmes. The Ministry is also highlighting images of partnerships and successes in collaboration with partners under various nominations.
- ◆ The Reserve Bank of India has set up a committee to review the fee structure of white label ATMs. The objective of this committee is to provide a common platform and industry model for all stakeholders. The primary one is the interchange fee, which is currently the same for both ATMs and WLAs operated by the bank. The rise of digital finance as well as shortages in the Asian continent have led to unstable operations.
- ◆ Union Minister Shri Jyotiraditya M. Scindia launched The Future is Now as the theme for India Mobile Congress 2024. They have also launched the India Mobile Congress 2024 application and website, which is a unique interactive app for registration. The minister also launched the pilot scheme for start ups and MSMEs. The objective of this scheme is to reduce the financial burden for startups and micro and small enterprises in the telecom sector.
- ◆ Urtula von der Leyen's bid for a second five-year term as President of the European Commission has been approved by the European Parliament. Von der Leyen received more votes than necessary to retain her as head of the European Commission, the EU's executive body.
- ◆ Indian Chamber of Commerce and Industry FICCI has estimated an annual average growth of 7.0 per cent for the year 2024-2025. FICCI's Economic Outlook Survey states that despite the stagnation, India's economic growth remains strong and the country remains one of the fastest growing economies in the world. The industry body said the average residential population for agriculture and allied allies is likely to be 3.7 per cent for 2024-2025.
- ◆ Cricketer Virat Kohli has topped the list to become India's most celebrated celebrity, boasting a brand value of \$227.9 million in 2023. However, this price is still less than the Supreme brand value of \$237.7 million in 2020, as reported by Crawley's Celebrity Brand Formulation Report 2023.
- ◆ Stepping Towards Excellence program was organized by MOHUA and the best performers were awarded under PM Swanidhi and DAY NULM. It was organized to honor the best performers under the PM Street Vendors Atmanirbhar Nidhi Yojana and Deendayal Antyodaya Yojana National Urban Livelihood Mission. Its objective is to provide working capital loans up to Rs 80,000 to urban street vendors without any guarantee.
- ◆ Union Mining Minister G Kishan Reddy launched landslide forecasting system in Kolkata. He said the Geological Survey of India projected landslides in Darjeeling and Kalimpong in West Bengal and Nilgiri in Tamil Nadu. GSI will prepare the forecast and send it to the state government, which will disseminate it to the district administration. The district administration will spread information among the people. Landslide forecasting system will be made available across India by 2030.

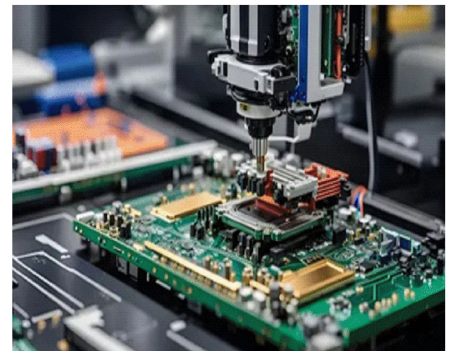
